- 3. The pay and allowances etc. are presently admissible as per the recommendations of 6<sup>th</sup> Pay Commission of the Govt. Other benefits include NPS, Medical reimbursement, LTC, etc. as per rules of the Centre in vogue and amended from time to time.
- 4. The experience requirement specified shall be the experience acquired after obtaining the minimum educational qualifications required for the post.
- 5. All educational, professional and technical qualifications should be from a recognized Board / University.
- 6. Persons working in Govt. or Public Sector Undertaking should apply through proper channel or produce the 'No-Objection Certificate' at the time of interview.
- 7. Outstation SC/ST candidates called for interview will be paid to & fro second class railway fare, as per GOI rules on production of the proof of the same. Candidates applying for deputation / permanent absorption may invariably get their application forwarded through proper channel.
- 8. The officers selected for appointment on deputation may either retain their grade pay in the scale applicable to them plus deputation allowance and other allowances as admissible in their parent cadre, or draw their pay in the appropriate grade indicated against the post.
